

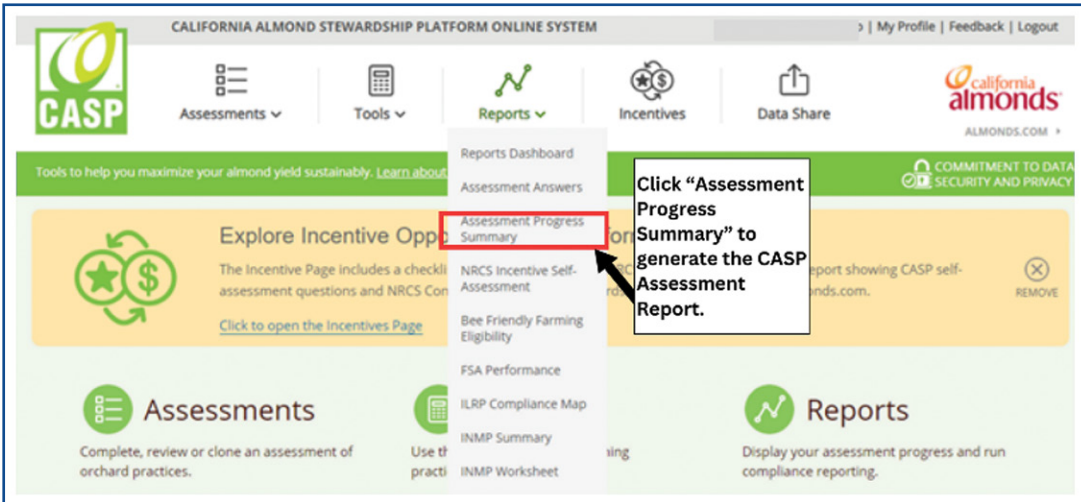
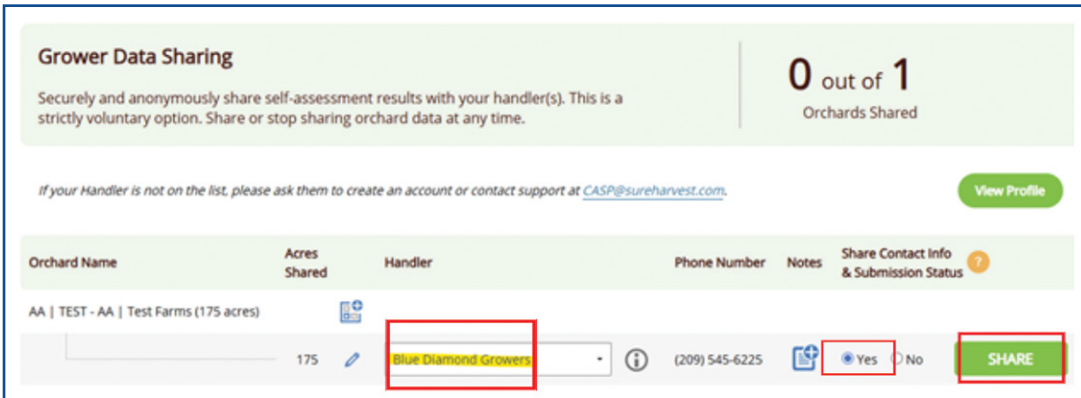
**2. Grower Data Sharing**

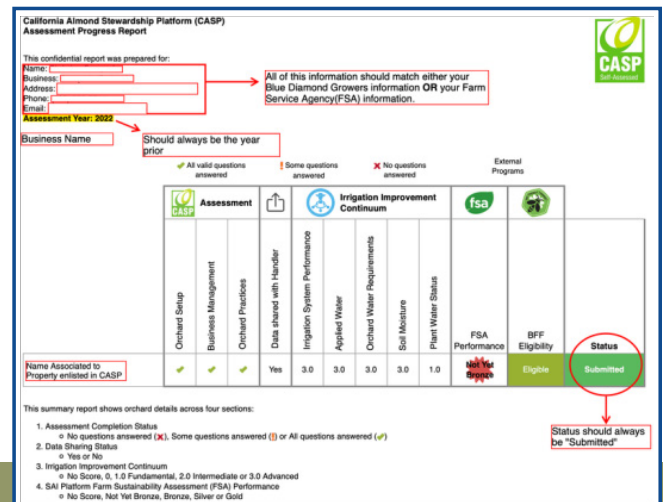
